Dear Stallion Owner,

Enclosed in this letter you will find a Stallion Yearly Breeding Report. Please complete this report with the details of the mares bred to your stallion for the 2008-9 breeding season, a fee of \$7.50 per mare bred and the completed report needs to be submitted to the PHAA before 1st July 2009. If you fail to submit this report by the due date you will incur an additional late fee of \$25.00 per mare bred. If no mares were bred we would appreciate you returning a report marked "Nil mares bred".

Mares that were bred to your stallion that will have foals that are not eligible for PHAA registration should still be included, however no fee is payable for these mares.

Through this reminder letter we hope that the PHAA has assisted you in complying with our breeding record requirements.

YOUTH INCENTIVE SIRES CLASSIC SERVICE SALE

Also included with this letter are the conditions and details of the Youth Incentive Sires Classic (YISC) Stallion Service Sale. This event has been conducted for the past four breeding seasons and has raised considerable funds for our PHAA Youth, either to attend the World Youth Games in Fort Worth Texas USA or contributed to the PHAA Youth Development Fund that was founded by Kevin Mills, Jeffrey and Lee Ann Hall for the education and advancement of the PHAA Youth.

The YISC event offers incentives for the stallion owner over a period of three years in return for donating a breeding service to their stallion, it also provides YISC futurity events for the progeny of the stallion, these events are conducted at the annual PHAA National Show.

As a result of the members vote at the 2009 AGM all registered progeny of nominated stallions are able to compete in the YISC listed events, this includes paint bred registered horses. On the positive side of this it will give the ability to have more participation for you the stallion owner and your clients in the listed events now open to regular or paint bred registered horses.

I am strongly committed and believe that through your participation we can offer our PHAA youth opportunities and experiences that develop them for their future. This event also gives you the opportunity to promote your stallion and his progeny. INSTRUCTIONS

IMPORTANT – we advise you keep a duplicate copy for

1. Keep a separate record sheet on each registered stallion used for breeding purposes;
2. Report shall be on file in the office of the Paint Horse Association of Australia (PHAA) no later than 1 July of each calendar year. Refer Rule 119;
3. Demand to see the registration certificate of each mare bred. This will assist you in the preparation of this report;
4. Be sure the last recorded owner of the mare is the person who contracts the breeding to this stallion;
5. Give exact dates bred. If more than one service is given be sure and show the different dates;
6. If pasture bred give date the mare was turned into the pasture and the date she was taken out of the pasture;
7. Keep a duplicate copy of this report for your files and future use. Send the original to the PHAA;
8. Mares on this report, if not registered with the PHAA must still be listed;
9. The owners or lessees of all registered Paint, AQHA or TB stallions on or before the first day of July of each year shall make a written report on forms furnished by the Association showing all mares bred to said stallion during the previous year. This includes all mares owned by the owner of the stallion as well as outside mares. Only Paint mares need to be reported by owners of AQHA or TB stallions.
10. Office copy of Breeding Certificates (Service Certificates) to accompany this report.
