RULES & REGULATIONS

1. For the Weanling and Yearling Halter Futurities at least one parent must be registered in the Regular or Paint Bred Registries of the PHAA provided that the Paint Bred parent itself has at least one Regular Registered parent.
2. The Owner and Exhibitor or Rider must be financial members of the PHAA.
3. Entrants must be in the Regular Registry of the PHAA (except for events nominated as Paint Bred only, for which entrants must be Paint Bred Registered). **No "pending" Registrations will be accepted after 31st December. If a horse is not registered by 31st December a \$33 penalty fee will apply.** Failure to have horse registered with PHAA by the final payment will result in the horse being excluded from the competition.
4. The Board of Directors will not cancel any Futurities because of insufficient entries.
5. **NO REFUNDS** will be given for any reason.
6. **NO LATE NOMINATIONS** will be accepted for the WEANLING FUTURITY OR PAINT BRED WEANLING FUTURITY for any reason.
NO BUY INS will be permitted in either the WEANLING FUTURITY OR PAINT BRED WEANLING FUTURITY.
7. Late nominations or payments (and buy-ins) in all other Futurities will be charged double the outstanding payments, then continue with other payments as per normal. In addition, a \$100 fee applies to buy-ins to the Yearling Halter futurities for horses whose dams were not nominated prior to their birth.

BUY-IN FOR THE YEARLING HALTER (FOR PROGENY OF NON NOMINATED MARES) IS PERMITTED PROVIDING A \$100.00 BUY-IN FEE IS INCLUDED. ALL OTHER PAYMENTS & RULES APPLY INCLUDING LATE PENALTIES. ALL FEES ARE NON-REFUNDABLE.

8. Ridden horses may be substituted only upon the decision of the Board, if the owner can submit positive evidence of disabling injury or the death of the animal nominated and also agrees to pay an additional 50% of the total payment. This applies only to the owner of the injured / dead animal and only in the Futurity event in which the animal was nominated.
9. An administration penalty fee of \$25- may be applied to forms incorrectly completed and requiring research of information to complete.
10. A \$300 Gelding Incentive prize will be awarded to the highest placed gelding in both weanling halter futurities.
11. A \$100 Amateur Owner Incentive prize will be awarded to the highest placed Amateur Owner in all ridden futurities.
