

## STALLION ADVANCE

(All fees inclusive of GST)

In order for your stallion to be registered for breeding purposes, the following must be received in the PHAA Office.

1. DNA test must be carried out before the stallion is used for breeding purposes. The DNA fee is to be paid to the office in advance, DNA kit will be forwarded once this fee is paid.
2. PHAA Veterinary certificate completed by a veterinarian.
3. The horses colt registration papers (a new set will be issued once advanced).
4. Two recent photos near and off side. (Four photos if previously unregistered).
5. Upgrading fee of \$485.00. This must accompany the application.
6. Please note – the DNA Kit is \$100.00, however if an Overo Lethal White Syndrome Testing kit is required the fee will be reduced from \$90.00 per test to \$82.50 per test if requested together with the DNA Testing fee.

**\*\*\* ANY COLT USED FOR BREEDING PURPOSES BEFORE BEING UPGRADED WILL INCUR A PENALTY FEE OF \$2000.00. ANY RESULTING FOAL WILL NOT BE REGISTERED UNTIL THIS PENALTY FEE IS PAID.\*\*\***
